

These samples were dissolved totally by pre-conditioning method according to below flow chart. (Cr^{6+} test method excluded)



多溴聯苯/多溴聯苯醚分析流程圖 / Analytical flow chart - PBBs/PBDEs







六溴環十二烷分析流程圖 / Analytical flow chart - HBCDD



四溴雙酚-A 分析流程圖 / Analytical flow chart - TBBP-A








