

PFAS Remark :

現有PFAS定量技術是分析PFAS物質的特定結構，但同碳數族群之PFAS酸及鹽類物質，其可被辨識的特定結構相同，因此無法區別所分析的特定結構是來自酸或者鹽類，故測試結果為同碳數族群之PFAS之酸及鹽類物質的濃度總合。下表PFAS物質濃度皆已包含在測試結果中，相關資訊請參見下表：(下表列舉PFAS物質僅為範例，並不包含所有同碳數族群之PFAS鹽類。)





鹵素分析流程圖 / Analytical flow chart - Halogen







雙酚A分析流程圖 / Analytical flow chart - Bisphenol A





聚氯乙烯物質判定分析流程圖 / Analysis flow chart - PVC






