PFAS Remark:

現有PFAS定量技術是分析PFAS物質的特定結構,但同碳數族群之PFAS酸及鹽類物質,其可被辨識的特定結構相同,因此無法區別所分析的特定結構是來自酸或者鹽類,故測試結果為同碳數族群之PFAS之酸及鹽類物質的濃度總合。下表PFAS物質濃度皆已包含在測試結果中,相關資訊請參見下表:(下表列舉PFAS物質僅為範例,並不包含所有同碳數族群之PFAS鹽類。) (The quantitative technology of PFAS is to analyze the specific structure of PFAS substances. 
鹵素分析流程圖 / Analytical flow chart - Halogen






